


Introduction

Project Description

Eric Wright Construction has been appointed as principal contractor for the design and construction of a new build, 1 x Form Entry, primary school on the existing school site.

Enabling works are scheduled to begin during week commencing 17 August 2015, to be followed by construction of the new building.

The new school building will be completed and handed over in May/June 2016 ready for the school to move in.

During June to September 2016, Eric Wright Construction will carry out demolition of the existing building and will reinstate landscaping as hard play area and car parking.





Questions & Answers

Will the work affect the existing school?

No, the school building will remain fully in use throughout the construction works. The site and deliveries will be segregated from the school. These are shown on the site logistics plan.

Is any access to and around the area restricted? No.

Will there by any road closures?

We do not envisage the need for any road closures.

Will there be any noisy periods?

Works will be undertaken utilising plant, equipment and techniques to minimise noise.
