Environmental issues are identified, managed and promoted by the company with a signed Environmental Pol January 2014. Environmental inspections are carried out fortnightly and Business Wise solutions are used reductions can be being made. Waste is being avoided with the implementation of the Site Waste Management Plan of mixed waste being reported as diverted from landfill. Paving has been reused on site. The environmental dashbo	for utilities n which sho	to see if ows 100%		

or mixed waste being reported as diverted from landfill. Paving has been reused on site. The environmental dashboard shows the site's energy and water usage as well as the carbon emissions. Bike racks are used to encourage workers to cycle to work. Eco cabins with light sensors and push taps are on site as well as a double bunded dowser with drip tray and spill kit for any potential hazardous spillages. There are *limited targets on site* however more are planned as bench mark data is collated. Lancashire County Council have recently been encouraging people to car share though care share week and the site has taken on board the scheme. Tree protection orders are in place with suitable fencing and signage. Noise monitoring is underway *following complaints during the demolition phase*.

Second visit update and score

The Company is 14001 accredited with regular environment audits and tool box talks. The Company has the benefit of a very pro-active Environment Manager, Joanne. Some facing bricks from the demolition have been saved for reuse and the rubble from the demolition crushed to 6F2 for the site works. Waste and CO2 feedback results are monitored as part of the suite of KPIs and the results displayed in the canteen and on the community notice board. *No contributions to the natural environment identified*.

The site ensures the safety through the arrangements details in the Construction Phase Plan (dated 15/08/2014). Fortnightly safety inspections take place and 8 first aid trained personnel (including subcontractors) are on site. Subcontractors are required to carry out weekly/monthly safety inspections by the health and safety advisors. Directions to the nearest A&E unit and the site's emergency plans are displayed in the canteen. A *fire drill has not yet taken place* as it is difficult to organise with the university. Positive intervention training organised which subcontractors have been invited to. A banksman is used to supervise reversing vehicles onto local roads and a gateman supervises the site entrance. Safety initiatives to ensure continuous safety improvements include recent training that involved a mock court cases for a ladder fall incident emphasising the importance of record keeping. The site safety noticeboard is located on the site gatehouse and is updated regularly. Accidents, incidents and near misses are investigates by the Health & Safety Manager to identify trends and prevent reoccurrence. Safety and risk information (including working at height and COSHH) is displayed on the noticeboard. The site has a segregated pedestrian route. Toolbox talks have been completed on Stihl saws and first aid. No of accident free days (175) is displayed.

Second visit update and score

Fire drills have now taken place. Non-English speaking operatives are given a translation of the induction and are required to have a "buddy" as part of the team who is fluent in English. The positive intervention initiative is working well, *no positive feedback to the workforce*.

5. Value their **Workforce**

First visit findings and score

The site demonstrates a commitment to the respect and fair treatment of all operatives through the site's Equal Opportunities Policy which is available in the back of the induction booklet which is kept in the site gatehouse. Anti-bullying and harassment posters are displayed. The site has provided a good standard of welfare facilities, including M/F toilets, a drying room, canteen facilities which were suitable for those of limited abilities, lockers, water fountain and a shower. Personal development needs of those on site are addressed through site specific tool box talks relative to the current activities and risks on site, most recently on Stihl saws and first aid. The health and wellbeing of operatives is addressed through HAVS monitoring and face fit testing, carried out by the health and safety manager. Cancer awareness signage is displayed in the induction room, canteen and toilets. A skincare system is on site to prevent skin conditions and the health and safety team regularly release new campaigns, the most recent of which being winter health, health and well-being and healthy living. A prayer room located in the university is available for those on site, and information is displayed in the canteen. A post box for near miss reporting is on site to encourage operatives to come forward and a bacon sandwich is rewarded for best health and safety comment. A cleaning regime includes daily cleaning of the facilities by a cleaner who visits the site for 5 hours a day. The company ensures the workforce feels involved and encouraged to give feedback. 100% of the workers have relevant, up to date CSCS cards.
