### Introduction

Eric Wright Construction are proud to be working on this new project for our client Peel Logistics.

This newsletter has been produced to inform surrounding businesses, transport users and the general public of the nature of the development, the parties involved and also our policy and procedures to minimise inconvenience during the course of the building programme. ## **Development Description**

- Construction of a high specification warehouse of some 16,500m<sup>2</sup> internal area with external HGV parking space, an external service yard, plus workforce and visitor car parking
- A new heavy goods vehicle entrance is being formed off Dakota Drive into a new service yard, and one of the existing entrances on Garston Shore Road has been opened up to form an entrance to the car park
- New soft landscaping is being planted around the perimeter of the building in line with the high quality of the wider business park

## Nature of the Works in the coming weeks

We carried out environmental and other surveys before starting work on site to ensure full compliance with the local authority and industry guidelines.

Extensive concrete, tarmac and soft landscaping works are currently underway. These ongoing works will mean lots of large HGV deliveries on to site that will come in through the business park from Speke Boulevard.

Traffic management measures remain in place on Dakota Drive which means the road narrows slightly. Please note the traffic warning signs around this area.

Our utilities contractor, PN Daly, is installing gas, water and electricity supplies to the new building from the existing underground services on Garston Shore Road that will entail some excavation in the footway.

Noise and dust is being controlled in line with the requirements set out by the planning authority. The surrounding roads are kept clean by regular road sweeper visits when required.

## **Questions & Answers**

#### Will any of the surrounding roads be closed as a result of the works

No – The work has been planned so as to keep disruption to a minimum for vehicle users and pedestrians alike. Some traffic and pedestrian management is in place and will be so until the end of July.

#### Where will contractors park?

All vehicles will be parked on site and contractors will be encouraged to travel to and from site in crew buses where possible to minimise our carbon footprint.

#### What will happen with the soil left on the adjacent site

Some material will be moved off site, some will be used to create a new level site for the proposed new building, and some landscaped mounds will be created in line with local planning requirements

#### Where is the main site entrance?

On Garston Shore Road, opposite Liverpool Sailing Club.


