## **Project Description**

The work involves the remodelling of an old barn. The new facility will be rejuvenated into a fresh, modern facility. The work will require the demolition and strip-out of existing stone walls, floors, roof and doors. Walls will be reconfigured with the construction of blockwork walls and stud partitions, M&E installations, new doors and casings, plastering, suspended and mf ceilings, floor finishes and decoration.

#### **Upcoming Works**

Over the coming weeks the roof installation will commence on site which will help progress the internal fit out of mechanical and electrical works and plastering. Windows and doors will be ongoing. Once these works have progressed we can start to strip the scaffold and proceed with the external works.

## **Questions & Answers**

#### Will the work effect the neighbours?

We are trying our hardest not to let the works effect any of the neighbours with delivery of materials coming as little as possible and trying to restrict the size of delivery wagons/vans where possible.

#### Will parking be affected?

Unfortunately with site compound being a tight area we are requiring a few parking spaces, but we are car sharing to avoid too much disruption.

#### Will there be any noisy periods?


Apart from when we piled early January, there are no further major noisy periods, just general day to day activities on site with the odd delivery.
