The project involves the construction of new office accommodation including a Category A fit out on one of the last remaining plots on Spinningfields

Nature of the Works in the coming weeks

Now that the super structure is well on the way the deliveries to site will be smaller in scale and less frequent than those that you will have observed thus far. We are employing the gateway at the Deansgate end of the job to receive deliveries except for small packages that come via the gates shown in the photograph on the front page. Our gateman's contact telephone number can be found on signage around the entrances should you need to contact him at any time if you have concerns with the movement of our transport around in the vicinity. The building will become closed in as the walls are fitted over the course of the coming weeks, followed by the windows and enhanced external finishes. I feel sure you will be surprised by the external treatment of the building when it goes on during the final stages of the build, watch this space!

You may also have noticed that we have a road closure in place to Sidney Street (with access to authorised vehicles and pedestrians only) to assist us in building the facades to this elevation and the rear which faces Invicta House along the other narrow way known as Tivoli Street. This limitation on access will also allow our safety measures to be employed in the most controlled manner possible.

The contractors who have been working on the old Courts have only a limited presence now that they have handed the building to the new occupiers making our own access more straight forward.
