Development Description

- Construction of a high specification 5 storey office building fronting onto Blackburn Railway Station
- Construction of a 60 bed Premier Inn hotel to the rear of the Cathedral
- Re-configuration of the surrounding roads and pavements to allow better public transport links
- A new bus interchange and taxi rank to the railway station
- Extensive public realm landscaping between the new buildings and Blackburn Cathedral

Nature of the Works in the coming weeks

The traffic management system will continue to change as the highway works continue to develop, with temporary traffic lights, signage and barriers controlling the traffic flow and pedestrian routes.

The hoarding surrounding the site will be completed to suit the final site layout and keep the general public safely segregated from site activities.

The taxi rank re-shaping will continue through the month of October.

The concrete and steel foundations to the two new buildings will be completed which entails a large number of delivery vehicle movements onto and off the site. Our gateman controls these movements around the site entrance and will be willing to speak to you should you be in the vicinity and have any questions. Please take care around the site with live traffic passing through all the time.

The steel framework to the buildings will be commencing in early October and the full scale of the buildings will be visible by the end of November.

Questions & Answers

Will the roads be re-opened ready for the Christmas shopping period?

Yes – The main road works will be either complete or the works suspended in line with the Council Christmas Embargo dates

Where will contractors park?

Some parking for construction workers is provided outside Bridge House within our car park, others will have to use surrounding town centre car parks

Will there be any noisy periods?

Noise will be kept to a minimum and we will notify you in advance via newsletter should anticipated levels become higher than normal

Constructors should provide a supportive and caring working environment


Working in Blackburn
