Will there still be access to neighbouring buildings? Yes.

When will the show home be open?

Late summer / early autumn.

Will there be any roadworks or road closures?

No, but possible footpath closures.

Will parking be affected?

Restricted to site entrance area due to works and materials delivery.

Will there be any noisy periods?

Yes, during demolition and piling works, however we will control this to a minimum.

Will there be any dusty periods?

All dust works will be wetted down as much as possible to keep dust to a minimum.
